Since joining GBU in 2018, Hunt has had a profound impact on the society's growth and culture and is known for his innovative initiative. Hunt has served in executive positions at major life insurance, annuity, and long-term care insurance carriers.

Patrick Mason, Supreme Secretary of the Knights of Columbus in New Haven, Connecticut was elected as Vice Chair, and Chris Martin, National President of Woman's Life Insurance Society in Port Huron, Michigan was elected as Secretary-Treasurer of the Alliance Board of Directors.

The board also appointed René Zanin, Interim CEO of Foresters Financial in Toronto, Ontario, to fulfill the remainder of the board term vacated by Louis Gagnon.
